1. Explanation of operating results

(1) Explanation of operating results for the quarter under review

During the first quarter of the fiscal year under review, the Japanese economy was expected to recover moderately as normalization of economic activities progressed and the employment and income environment improved, especially among major companies. Consumption by foreign visitors to Japan is also at a high level due to the expansion of inbound tourism. On the other hand, the situation remains uncertain due to continued inflation, monetary policy developments in the United States, geopolitical risks in the Middle East, and unstable financial and capital markets.

Under these circumstances, the Laox Group (the "Group") has formulated the Medium-term Management Plan (FY2025 to FY2027) to realize its management philosophy of proposing a rich and varied lifestyle, or "Global Life Style" and supporting its evolution and creation, and to have renewed business growth. In order to respond flexibly and swiftly to the rapidly changing business environment and to strengthen the competitiveness of the Group as a whole and to restructure the business portfolio, we will implement various measures under the four key strategic themes of "investment for reform and growth with priority on earnings," "further selection and concentration," "expansion/shift of customer segments," and "maximization of group synergies."

In the Gift Solution Business, we are strengthening our lineup of premium sweets, starting with collaboration products. In addition, under the policy of "selection and concentration," we will consolidate and close duty-free retail stores in the Retail Business in order to optimize the allocation of management resources, and move forward with initiatives to build the next store structure.

As a result, net sales for the first quarter of the fiscal year under review decreased 10.1% year on year to 11,477 million yen as we fail to completely capture consumer needs during seasonal changes at our apparel shops in the Retail Business. Operating loss was 1,047 million yen (a loss of 902 million yen in the same period of the previous year) while ordinary loss was 1,183 million yen (a loss of 798 million yen in the same period of the previous year). Loss attributable to owners of parent was 1,232 million yen (a loss of 799 million yen in the same period of the previous year).

Operating results for each business segment are detailed below.

(Gift Solution Business)

In this segment, we mainly sell Western confectionery as gifts, miscellaneous goods and lifestyle-related goods, and offer various services such as operation of logistics facilities, e-commerce websites and call centers.

For the "THE SWEETS" private brand of Western confectionery, we work to expand sales channels through the development of new products and new flavors. With regard to services, we create synergies within the Group by taking advantage of the functions we have developed through the sale of gift products and by applying the experience to logistics operations for apparel and e-commerce operations.

As a result, segment net sales for the first quarter of the fiscal year under review decreased 9.4% year on year to 6,195 million yen, and segment loss was 268 million yen (a loss of 329 million yen in the same period of the previous year).

(Retail Business)

In this segment, the number of foreign visitors to Japan continued to increase at duty-free stores and achieved a record number of visits in January. Given the solid inbound tourism, the gross margin remained at a level higher than the previous year due to the strengthening of sales of high-margin products. In February, we opened a pop-up store to flexibly meet demand. On the other hand, in line with the review of our business strategy, we are consolidating our stores. In addition, apparel shops, which mainly target domestic customers, performed well due to the annual large-scale sale in January. Meanwhile, growth in February was somewhat sluggish on a year-on-year basis due to the closing of the Seibu Shibuya store and the impact of low temperatures.

As a result, segment net sales for the first quarter of the fiscal year under review decreased 9.8% year on year to 4,803 million yen, and segment loss was 430 million yen (a loss of 223 million yen in the same period of the previous year).

(Trading Business)

In this segment, Kurogi, a Japanese restaurant operating in China, focused on attracting new customers and increasing brand recognition while holding the anniversary dinner party and offering party menus for Japanese companies under the theme of "Pursuit of the Heart of Japanese Cuisine." In addition, we are analyzing customer needs in the Chinese market and making efforts to resume business in the future.

As a result, segment net sales for the first quarter of the fiscal year under review decreased 70.7% year on year to 84 million yen, and segment loss was 14 million yen (a profit of 6 million yen in the same period of the previous year).

(Asset & Service Business)

In this segment, we are engaged in the brokerage business for commercial facility properties and in the management business for properties owned by the Group companies. The occupancy rate of commercial facilities has been on a gradual upward trend as a result of active efforts to replace tenants and attract new types of businesses. We are also working to improve cash flow by liquidating and selling idle properties owned by the Group and to improve profitability by reducing costs.

As a result, segment net sales for the first quarter of the fiscal year under review increased 24.6% year on year to 392 million yen, and segment loss was 31 million yen (a loss of 52 million yen in the same period of the previous year).

(2) Explanation of financial conditions for the quarter under review

(Assets)

Total assets at the first quarter of the fiscal year under review amounted to 38,100 million yen (44,061 million yen at the end of the previous fiscal year). This was mainly due to a decrease of 1,724 million yen in cash and deposits and a decrease of 4,528 million yen in notes and accounts receivable—trade.

(Liabilities)

Total liabilities came to 16,519 million yen (21,070 million yen at the end of the previous fiscal year). This was mainly due to decreases of 3,326 million yen in notes and accounts payable–trade, 128 million yen in electronically recorded obligations–operating, 150 million yen in short-term borrowings and 690 million yen in current liabilities and others.

(Net assets)

Total net assets came to 21,581 million yen (22,991 million yen at the end of the previous fiscal year). The drop in net assets was attributable primarily to a decrease of 1,232 million yen in retained earnings.

(3) Explanation of information on future predictions such as consolidated results forecasts, etc.

There is no revision to the consolidated results forecasts announced on February 14, 2025. The forecasts are based on information currently available, and actual results may differ from the forecasts due to various factors.
